BEHAVIORAL GUIDELINES

Please review these behavioral guidelines with your child, and be sure they understand them completely. Both parent/guardian/camper are required to sign the bottom of this page to show you fully understand and agree to the following terms.

My child will adhere to the following rules:

- Be respectful to all peers and adults regardless of whether they're participating in the camp or not.
- Use of appropriate and kind language.
- Keep hands and feet to themselves.
- Treat all Sunriver Preschool/Sunriver Discovery Camp/Fellow Camper's property with respect.
- Avoid behavior that may jeopardize the health and safety of themselves or others.

All Camp personnel are experienced teachers and trained in positive reinforcement, redirection, and developmentally appropriate behavior management skills. Teen leaders are trained to refer to the Camp Teacher(s) for any conflicts. Sunriver Discovery Camp's goal is for your child to have an amazing week of learning, fun, and forming of friendships.

Therefore, if any camper does not follow the behavior guidelines, Sunriver Discovery Camp personnel will take the following action steps as behavior problems progress.

1. Staff will redirect the camper to more appropriate behavior.
2. The camper will be separated from the other campers momentarily, while being reminded of behavior guidelines and camp rules and the camper will be asked to decide on action steps to correct their behavior.
3. If the behavior issues continue and/or escalate; the camper's parents/guardians will be contacted, and the camper may be dismissed from the camp without refund. This is on a case-by-case basis and at the sole discretion of the camp Director.

Any camper who is caught fighting, stealing, damaging property, or displaying behavior that goes beyond our normal disciplinary action step's outline; may result in immediate and permanent dismissal from the camp without refund.
